# Fare schedule - Paratransit

Effective July 1, 2025

#### **RIDE FOR FREE**

**Children aged 11 and under** can travel for free at all times while accompanied by a person aged 14 or older who is supervising them. The accompanying person must have a valid ticket.<sup>1</sup>

**65 and over:** Free for residents of the agglomeration of Montréal for all modes in Zone A (bus, métro, train, REM and paratransit). For trips on the regular network only, the Free 65+, All Modes A fare must be loaded onto an OPUS card.
